Family Housing



A transitional accommodation program for families who are experiencing homelessness and needing help to build tenancy skills.

The Family Housing Program

The program is a transitional accommodation service for families who are experiencing homelessness and require support to build their tenancy skills. The Family Housing Program is able to provide supported accommodation to families who wish to actively engage in a support plan whilst being housed for up to 12 months.

A Housing Case Manager visits the family weekly and works alongside the family to develop a support plan that is appropriate to the family's strengths, needs and goals.

Housing Case Managers assist with:

- Advocacy and referral
- Budgeting
- Tenancy skills
- Employment, education & training links
- Transition to independent long term housing
- Support to links in with the community

The service has properties located across Perth metropolitan area, close to schools and community facilities including public transport.



Eligibility:

- Experiencing homelessness and have a support need relating to maintaining and sustaining a tenancy
- Two or more children under the age of 16, in their care for the duration of support and receiving full Centrelink payments for the children
- Eligible for the bond assistance loan and priority waitlisted with the Department of Communities – Housing
- Willing to actively engage in a support plan
- Remain within the income limits for social and community housing eligibility

Referral Process

Agencies can refer eligible clients to Family Housing via the Family Housing Enquiry Line on 08 9528 0735 or by emailing a referral form to housing@anglicarewa.org.au. A phone intake will be held and eligible families will be accepted onto the waiting list.

Waiting List

To remain current on the Family Housing Waiting List all families are required to contact the service fortnightly. Families need to remain eligible for the program to stay on the waiting list. During high demand periods, the waitlist may close to new applicants.
